# **WHAT'S NEW?**

#### JUNE 2016

#### MEMORANDUM OF UNDERSTANDING – GOLF COURSE

As of February 2018, the permit to operate the District's landfill site will expire and will no longer be available for disposing of garbage. The site will be decommissioned, with reclamation and final closure commencing after closure date.

To offset some of the District's costs in decommissioning and long-term monitoring of the landfill site, the District has entered into a Memorandum of Agreement with the Katepwa Beach Golf Club Inc. for a minimum lease period of twenty-five years with an option to extend the lease at the landfill site for an additional twenty-five years. In decommissioning the landfill site, the District is responsible to place a final cover over the landfill area. It is anticipated that some of the existing soil from the Golf Course parking hill can be used as final cover, and or appropriate soil material can be found in the area around the landfill and golf course property. The ongoing monitoring of the piezometers and such other wells as set out in the District

Integrated Landfill Plan, shall be the responsibility of the District and will continue to be so. The Golf Club will be responsible to provide a seed bed base over the final cover, and maintain the landfill site to ensure any erosion that may occur is repaired and the slopes are maintained on a go forward basis. During the lease period, the Club can use the lands as greenspace but would obtain approvals to use the site for any other purpose other than greenspace.

# ZONING AMENDMENT BYLAW NO 2-2016

Bylaw No. 2-2016 was passed to amend Section 5.2 R/R - Resort Recreational – Garage Side Yard Setback to 3m (10 feet), and amend Section 5.6 UH – Urban Holding – Minimum Site Area to 5 acres.

#### LAND AGREEMENTS – KATEPWA ROAD

Agreements were signed with Tim and Sherri Stoll and Raymond and Janet Hammond to purchase the necessary lands to relocate a portion of Katepwa Road around the slumped portion of the road.

The roadwork is now completed, and the paving was completed by City Wide Paving.

# **BYLAW OFFICER**

An agreement was signed with Josh Olinik of Fort Qu'Appelle for the contract position of Bylaw Officer. The duties include the enforcement of municipal bylaws, representing the District of

Katepwa before a justice of the peace or provincial court judge, including towing, impoundment and providing a compound site.

# WASTE COLLECTION - WEEKLY BAG LIMIT

A resolution was passed to increase the weekly bag limit per residence to a four (4) bag limit.

This will increase the material at the Landfill, reducing the required amount of fill material and associated costs thereof, required at closure.

# **DUST CONTROL**

On June 30<sup>th</sup>, dust control was performed throughout the District by Mark Sinclair of By-Pro.

#### LAGOON DEBT

On June 30<sup>th</sup>, the lagoon debt was paid off. The cost to construct the lagoon was approximately \$2,200,000.00 and the original loan amount was \$1,800,000. The loan had been scheduled to be repaid over a ten year term, from 2013 to 2023. With the early pay out, the District saved \$322,845 in interest.

# JULY 1<sup>ST</sup> CANADA DAY

July 1<sup>st</sup> started off with wonderful music by the bands Len Gadica, Colby Nargang, the Blazers and Audacity and a ribbon cutting ceremony for the Love Your Lakes Program. Security was provided from 3:00 p.m. to midnight with no altercations reported; and finished off with a great display of fireworks produced by Paradise Fireworks.

A "Big" Thank You to Councillor Murray Penny for organizing the music event! Murray has confirmed that he has booked the Blazers and Len Gadica for the 2017 July 1<sup>st</sup> and is hoping to also book Brenda Lee Cottrell.

# STARS CLASSIC GOLF TOURNAMENT

The 2<sup>nd</sup> Annual Katepwa Stars Classic was held in July. There were 80 golfers and 100 in attendance for the dinner. They raised \$9,700.00 for STARS through golf fees, donations, 50/50 draw, extend-a-putt string sales, putting contest and silent auction.

#### CERTIFIED WASTEWATER OPERATOR

An agreement was signed with Tim Rosenthal of Neudorf for the contract position of Wastewater Operator to comply with the requirements by the Water Security Agency and the permit to operate.

#### BRIDGE WORK - ROAD MAINTENANCE AGREEMENT

An agreement was signed with the Saskatchewan Ministry of Highways and Infrastructure for the replacement of the bridge along Highway #56 over Vidals Creek. The bridge work will consist of the replacement of the existing culvert, conducting repairs to the creek, restoring road to its original condition and adding a 1.5 metre walkway with railing alongside the bridge. The additional construction of the 1.5 metre walkway will be funded by the Local Trans Canada Trail Committee and the District of Katepwa of an equal contribution of \$10,000 each.

The bridge work will commence in November and be completed by January. The Ministry of Highways will be performing the work, and the days of work will be from Monday to Friday. Highway #56 will be open to regular vehicle traffic, boats, and trailers, however overweight trucks will not be permitted. Signage will be erected at each of the District's boundaries. In conjunction with this bridge work, the Ministry of Highways will also be performing work on the bridge near Sandy Beach

# **DECLARATION OF ELECTED OFFICIALS**

The newly elected Council were sworn in at the August 16<sup>th</sup> Regular Meeting, and the Declaration of Elected Official were signed.

#### **RE-NAMING TO KATEPWA ROAD**

In early August, letters were sent to residents that had a civic address of Lakeside, Lakeview, Osment Place and Osment Road to advise them of the renaming of the major artery into the area to Katepwa Road, and of the Public Meeting scheduled for August 16<sup>th</sup>. At the August 16<sup>th</sup> Regular Meeting of Council, the Public Meeting was held and Bylaw No. 5-2016 was passed for renaming the road. The plan amendment for renaming has been registered with Information Services Corporation.

# **LAND PURCHASE AGREEMENT**

A purchase agreement was signed with Joan and Audrey Stephens for the 0.71 acres of land that was encroached upon by the adjoining landfill site.

# **GOLF CART BYLAW NO 8-2016**

For insurance purposes, Bylaw No. 8-2016 was passed to include for the use of golf carts by the members of the local Trans Canada Trails Committee to perform maintenance along the trail.

#### TAX ENFORCEMENT – LOT FOR SALE

An advertisement was placed in the Fort Times, Indian Head – Wolseley News and on the District's website of a lot for sale by tender. The property is located at #158S Katepwa Drive;

Lot A, Block 1, Plan No. EY4410 and zoned Lakeshore Residential. The lands are serviced with power and gas up to the parcel's boundary. The total square footage is 11,326. Tenders were to be sealed and delivered to the District office by 4:00p.m. Friday, September 9, 2016.

Since the advertisement, the office has received a claim by the original owners of the skidoo, ice shack, pontoon trailer, kayak and canoe that are located on the lands. In speaking with the RCMP, if a claim can be proven the items must be returned to its rightful owner. The original owner of the lands has confirmed the claim. Our office will be re-advertising the lot for sale by tender to explain the removal of items and to extend the deadline for the submission of tenders.

# **CALLING LAKES BRANDING COMMITTEE**

The District will be purchasing three (3) reflective signs with the logos "District of Katepwa and "Valley of Festivals" to be placed at each entrance point of the District's boundaries.

# **BALCARRES FIRE PROTECTION SERVICES**

The Balcarres Rural Fire Association and the Town of Balcarres provide fire protection services to the District of Katepwa. As of January 1, 2017, the current rates will increase 2% and by an additional 2% each year thereafter. The 2017 rates as follows:

- Annual Fee \$15,300;
- Fire Call \$750 plus an additional \$375 per hour after the first hour; and
- \$27.50 Per Man/Per Hour plus expenses

# NORTH VALLEY WASTE MANAGEMENT AGREEMENT

As an alternative for landfill services after we close our current landfill site, a bylaw was passed and an agreement was signed with North Valley Waste Management accepting the following provisions:

- District's Per Capita will be based on a population 411 persons.
- A buy-in fee of \$75.00 per capita to cover a portion of the undepreciated capital cost of assets.
- A per capita fee of \$65.00 towards reserve funds.
- The 5% annual operating budget fee will be waived until the District commences hauling waste to the NVWM Landfill. The fee will be prorated for the year in which the District commences hauling waste.
- North Valley Waste Management will waive the 5% fee that would be levied if no municipal waste is brought to their landfill site.
- The District's residents will be permitted to haul yard debris, including branches and trees at no charge, from the time the District enters into an agreement, and before the District commences hauling municipal waste to the NVWM landfill site.
- Upon both parties entering into an agreement, the residents and contractors of the District will be assessed a member rate tipping fee.
- The District is allowed to amortize the buy-in over 5 years with the first payment to commence in September 2016.

- To withdraw from the NVWM Authority, a notice must be submitted to the Authority and the other member municipalities at least one year prior to the date of withdrawal.
- The Authority may expel the Municipality from membership if refusing to meet financial obligations. The notice to expel is effective 60 days after the municipality has received written notice. A Municipality expelled, is required to pay its entire capital assessment due under the agreement for the one year in which it was expelled.
- A Council of a Municipality shall appoint One (1) representative annually to the Authority. The Representative is entitled to one vote.
- Member Municipalities will be sent an annual audited financial statement.
- The Board shall review annually the formula for the capital and operating costs of the Authority. If there is a change in the funding formula, the new formula will be presented for consideration and approval to the member municipality councils. The new funding formula must be approved by at-least two-thirds of the member municipalities.
- The term of the agreement is indefinite. Any changes to the agreement must be made in writing and approved unanimously by each municipality enacted by a bylaw.

The 1<sup>st</sup> year payment of the buy-in was budgeted for and will be paid in September.

# SASKTEL – HIGH SPEED INTERNET SERVICE

At the August 16<sup>th</sup>, 2016 Regular Meeting of Council, a resolution was passed to proceed with the installation of infrastructure for the SaskTel High Speed Internet Service.

To inform the residents of Council's decision and address questions, a Public Meeting was held on Saturday, August 27<sup>th</sup>. SaskTel Representatives were in attendance and provided the following comments:

- SaskTel's contribution towards the project is the existing infrastructure and the connectivity to the network, along with the installation of cabinets required every 2200 meters around the lake.
- If a property owner signs an application and later sells their property, the property owner is not bound by the signed application and will be able to cancel service.
- When you submit a signed application, you are agreeing to subscribe to the SaskTel High Speed Internet Service at your location for three years (this means 12 months of each year for 3 years of monthly bill payments). This sign up helps the District toward reducing its share of the total infrastructure cost. Both Seasonal and Permanent residents are welcome to submit a signed application as long as you are able to commit to subscribing for the full three year commitment period. Only those signed applications agreeing to the 3 years will be eligible in the calculation of infrastructure cost reduction. However, upon SaskTel completing the installation, the internet service will then be available for connection to all residents in the District.
- The property owners that choose not to submit a signed application, can connect and disconnect service at any time. To disconnect, SaskTel's fee is \$35.00. The maximum length of time for disconnection is 8 months. For reconnection, there is no fee.
- The high speed internet service is a dedicated wired service, so there will be no limit to data that a property owner can download and no throttle back or slow down. The service will provide unlimited usage.

- Satellite competitors are vulnerable to weather conditions and periods of slow service.
- The hot spot on a phone is more prone to congestion and slow down because of sharing a tower.
- Fusion is more expensive, it is a shared service, and vulnerable to throttle back and slow down
- If a property owner does not currently have a physical line into their home, the installation will be an additional cost to the property owner. When the line is activated there is no rental charge for the line.
- The deadline to submit signed applications has not yet been determined. A Memorandum of Understanding will be signed by SaskTel and the District. Upon the Memorandum of Understanding being signed, no further applications will be able to be accepted as an offset towards the infrastructure cost.
- During the installation, SaskTel will be the direct contact for any concerns or issues that may occur.
- A \$5.00 credit will be applied for those that wish to bundle their SaskTel Services. The services eligible include cell phone, Securtek and landline long distance package.
- Max Television will not be available through the high speed internet service. SaskTel is currently in the planning stages in developing an internet television product to work with the subset channels from Max television.
- The installation of the high speed internet service can also connect to overhead phone lines.
- SaskTel anticipates having the high speed internet service installed by the fall of 2017.

Front street pickup is from October 1st to April 30th.

#### LANDFILL SITE

<u>Summer hours</u> from May 1 through to October 31 - Monday, Friday, Saturday 9:00am to 5:00pm.

Winter hours are Mondays from 9:00am to Noon.

For access to the landfill outside of regular hours please contact our Landfill Operator, Jerry Stremick at 306-331-9317. The fee is \$20.00 for the call out plus the fees for the load.

Items that <u>are not permitted</u> at the landfill site include: mattresses, box springs, couches televisions, railway ties, and used oil.
